- Hol H. Clark Park Ramp-Robert, Supervisors passed a development waiver, first phase for emergency services, not recreational users. The county has a budget.

# **6. Delaware River Tributaries and new designations presentation**— Robert McEwan and Tara Mezzanotte (10 min)

- Tara-Pohatcong Township is supporting their Pohatcong tributary. In August, township plans to pass a resolution for being a LDWS municipality. ORV gristmill along Phoatcong tributary.
- Tara-Paulinskill Land Conservancy of NJ, Paulinskill Community NJ Highlands Coalition, NJ Sierra Clublocal chapter, Highlands involved. Presented to Conservation Committee for the NJ Sierra Club, they support the designation study. NJ Sierra club approval allows local Sierra groups to become involved with tributary study. Appalachian Mountain Club-received letter of support. Going in front municipal EACs and Warren County.
- Robert-Thanked partners for support.
- Robert-Lambertville, Stockton, Riegelsville to approve section of river.
- Met with Hopewell, Delaware Township, and Bridgeton Supervisors. Endorsements from Natural Lands, Canal 21, FODC, and Bucks Audubon plus residents.
- Lois-Durham Township agreement with Cooks Creek Watershed Association to work together on Cooks Creek erosion grant. Waiting to hear back on grant approval. Township has not joined LDWS even though numerous W&S meetings and presentations over the years.
- Adam-mentioned the Lenape Nation of PA monthly newsletter, invited MC member to send anything publicizing along such as the tributary study.
- Alan-NJ Commission on American Indian Affairs can help promote as well.

## **8. Ongoing Matters** (25 min)

- Rockfall Mitigation Projects/NJDOT Tara Mezzanotte
  - Richard another meeting today with NJDOT for Devil's Tea Table and Byram. Called Local Design Group meeting, many participants had questions about the basic science. At end of meeting, NJDOT said they are moving forward regardless.
  - Richard-Rt 78 rockfall mitigation mostly closed the road after blasting. Known area for issues with water. Why does NJDOT not focus on that area?
  - Tara-Rt 46 landslide closed road, DEP owned land. Tara- State knows there is an issue with old RR tunnel. Not in rockfall mitigation area.
  - Tara-NJDOT claiming the need to replace entire retaining wall (touches the river) in S-curve.
     Four panels are critical. Signed contract to replace before any studies. Same project area in rockfall mitigation project. Together \$204 million. Originally \$1.4 in 2011.
- Springfield Quarry- <u>Coalition</u> is appealing the township's decision to approve (with conditions)
  - No update on appeal
  - o Faith-Delaware Riverkeeper is tracking as well.
- Warehouse projects
  - Judy-River Point Logistics, Mt. Bethel, PA-Judith-Primary 2 candidates won that have an interest in sustainability. Developer working to get approvals before election. Challenging

Demi Road water treatment/sewer. I-3 subdivision was deemed cleaned. Powerplant area was deemed hazardous, and they can begin work. Trees supposably hide a 40 ft or 100 ft viewshed from river. The developer wants to change 3 of the buildings on 800 acres into one (13 in total originally proposed). Upcoming meeting for drip irrigation, township create wastewater treatment, and drop water into another watershed.

- o Jaindl, White Township, NJ
  - Fred-Riverkeeper trying to get it thrown out without prejudice. County requires a new access point to property. Township solicitor to wrote to Jaindl, if they don't come to the August meeting with substantive presentation, the township will vote for the denial. White Township changed the zoning, cannot resubmit same application. Will result likely in lawsuit.
